# <u>Ingrid Weitzel is Named</u> <u>English Language Learner of the Year!</u>

Ingrid Weitzel had no idea that twenty years after coming to this country, she would not only be the talk of Kewaunee County, but the State of Wisconsin! Ingrid was nominated by tutor Jerry Waara and Bob Garfinkel in an annual promotion by Wisconsin Literacy to honor the "Outstanding Language Learner of the Year," as well as "Tutor of the Year" and others contributing to literacy in the State of Wisconsin. Little did Ingrid know that this was the start of a week that she would never forget!

On October 17, 2011, five Literacy Partners Board members and about 15 employees of Union State Bank gathered around Ingrid's desk. I had the honor and privilege to read a proclamation that all in attendance will remember forever. It was a proclamation by Governor Scott Walker declaring October 19, 2011 as Ingrid Weitzel Day in the State of Wisconsin. This is the day she received the award from Wisconsin Literacy.

The next day, Jerry escorted Ingrid to the Kewaunee Board of Supervisor's meeting. I introduced both guests and they received a rousing applause. On Wednesday, Jerry, Ingrid, Barb Baldwin and I attended the State Literacy Convention in Appleton. Before a crowd of 510 literacy instructors, directors and adult education dignitaries, Ingrid was awarded a beautiful plaque and she delivered a wonderful speech to the huge audience. Ingrid thanked Literacy Partners and Jerry for helping her gain citizenship and literacy skills.

The week to remember did not stop here. Union State Bank had an informal lunch for Ingrid on Friday.

I told Ingrid how proud of her we all were and she expressed her gratitude for all the recognition. She also said, "I am thankful for all of the attention and praise this week, but I am glad it is over. It is difficult being well known. At this point, I want things to get back to normal!"

I not only respect Ingrid for her accomplishments, but for her willingness to give back to the very organization that helped her. Last month, Ingrid was certified as a trained tutor in our literacy program. Jerry summed everything up very well: "Ingrid has a great feeling of empathy for immigrants since she went through the process herself, and that is a great gift for her to give to her students. She knows the importance of education and learning English, and there is a bright future for her whatever she decides to do.

#### Introducing Our Tutor of the Season

I'm wishing it was Student/Tutor of the Season. So much of what I do is a direct result of Mina's (and Noel's) hard work and dedication to learning. I'm the facilitator and guide for their accomplishments.

I was excited by the opportunity to tutor. I had inquired before the Kewaunee County Literacy Partnership was established about tutoring in Green Bay. I was not thrilled about the travel that it would involve and at the time there was a 6 week course that was required and a \$45 fee for the course. That discouraged me. When the Kewaunee County opportunity presented itself, I felt like it was time for me to "step up."

I have a background in Elementary Education as a teacher for many years. I am the mother of four and now a grandmother of four with another on the way. I was aware of the need in our community for this program and wanted to help if I could. I'm not sure when this all happened. I was in the first class of tutors, I think. We met at LC Junior High.

My first student was a young Hispanic gentleman who did not speak much English at all. We arranged to meet using an interpreter. Our first meeting was very primary, but Noel was very serious about his classes and we quickly made progress. He became more confident. We met for maybe 18 months and then he moved back to Mexico. I often wonder about him and how he is doing. I know he will be successful in whatever he does. He was very goal oriented. He worked here to build a home for himself and his fiancée that he moved into when he returned to Mexico. Noel showed me the video of his new home before he went back.... it was beautiful.

Mina is my present student. Mina is an amazing mother and grandmother. She makes tutoring easy. She works ahead in every lesson and often quickly moves through the lesson because she has worked ahead. You can't ask for more than that. Mina and I meet twice a week, but she also travels back to Cancun for family visits about 4—6 weeks at a time. She is currently working on obtaining her U.S.

citizenship. That has been so educational for me. There is a lot to study since the test includes a reading and writing component, and the civics questions are asked in English. Mina has studied so hard and I am confident that she will pass on her first try! I get most excited about her ability to converse with me before our class begins. We talked for about 15–20 minutes recently. We were both so happy!

I find tutoring to be very rewarding. I've made two friends that are genuinely grateful and gracious about their commitment to learn English. They have both been able to be open to making mistakes and asking for help. That is not easy. I have the easier of the roles. Whenever I worry about a lesson or concept, I just think of how difficult it must be for them. We learn and laugh together, occasionally being frustrated, but always willing to work through it. When I think of how much my students have accomplished, I am privileged to be a small part of it.

I am so grateful for the Literacy Partners organization. The Board of Directors and Bob Garfinkel are dedicated and hard working. They are real heroes who give so much time and energy to maintaining this group. It is an endeavor that is so needed in our community!

Our literacy board and committees take your responses to our annual survey seriously and plan the next year's activities based on its results. The survey question is stated with a short result summary and President Bob's response. Thank you to the 26 tutors responding to this survey. The percentage may be over 100% due to possible multiple responses.

1. Additional materials needed at our Hillcrest School Resource Center:

Results 44% Beginning writing activities

38% Bilingual books

38% Samples of other reading series

<u>Bob's Response</u>: Our support group has responded to this survey by ordering and receiving over 40 bilingual books. More will be on tap for 2012. We will search for quality writing materials and since we are reviewing new texts, additional reading series will be added to our center when the process has been completed.

2. Has your student been promoted or attained a new job as a result of our program?

Results Five students have been promoted or gained employment due to our program.

<u>Bob's Response</u>: We are proud of our students and their accomplishments which include: Licensed food manager, licensed cosmetologist, interpreter, farm supervisor, and full time employment.

3. Has your student achieved any personal goals or accomplishments?

Results: Eleven students have achieved personal goals.

Bob's Response: Each student had their own specific goal.

4. What literacy workshops would you be interested in 2012?

Results: 80% Immigration Issues

45% Ways to improve spelling

40% Improving reading comprehension

40% Hispanic culture

<u>Bob's Response</u>: The tutor and student support groups plan our workshops. They have this survey and will plan the 2012 calendar around it.

5. What would be the number one thing we could do to help you instruct your student more effectively?

Results: Adopt a textbook that is up to date and interesting

Ideas to help my student with pronunciation

Provide useful grammar worksheets More opportunities to talk to other tutors

<u>Bob's Response</u>: There will be a text selection committee forming soon. Call Bob if you want to get involved. At least one tutor get-together to share ideas will be on the 2012 calendar.
